Cancellation Policy: Liberty Landing Marina will refund a reservation deposit, minus a cancellation fee, provided the reservation is cancelled no less than 48 hours prior to 12:00 noon on the arrival date. Cancellation Fee is 5% of total reserved slip amount or \$25.00 whichever is greater. If the reservation is cancelled less than 48 hours prior to 12:00 noon on the arrival date, then the entire deposit is forfeited. Vessels over 75' cancelling, forfeit entire deposit regardless of when reservation is cancelled. In the event the reservation is not cancelled, and the above vessel fails to arrive, regardless of reason, Liberty Landing Marina will charge the above credit card for the total reserved slip amount.

Key Card Agreement: By accepting the electronic access key(s) issued to me, by Liberty Landing Marina, for temporary access to the marina, it is understood that any keys issued to me are to be used in accordance with Marina policy. It is further understood that Liberty Landing Marina cannot be held responsible in any way for any actions resulting from the use of the keys issued, and that LLM reserves the right to terminate keys at any time. It is also understood that any keys issued to me are to be used only for the duration of my stay at Liberty Landing Marina, and must be returned to LLM at the end of my stay before departing the Marina. I understand that a \$25 fee will be applied to my account for each key not returned. **Initial:** _____

Measurement Policy: Liberty Landing Marina charges for the entire overall length of a vessel and its appurtenances. If the overall length, as measured by Liberty Landing Marina, is 2 feet, or more, greater than the indicated length above, the additional length will be charged at twice the prevailing transient rate.

Mulihull Vessels: Catamarans will be charged 1.5 times and trimarans will be charged at 2 times the prevailing transient rate.
