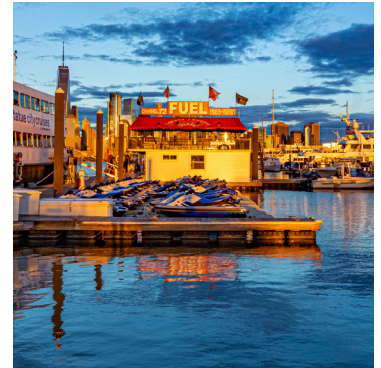
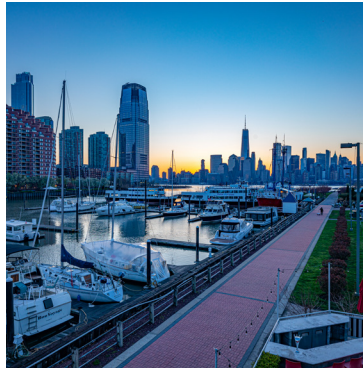

- **Note:** Slip(s) assigned on your confirmation is subject to change upon arrival. Prices are subject to change without notice.
- **Cancellation Policy:** Liberty SMI OpCo, LLC ("OpCo") will refund a reservation deposit, minus a cancellation fee, provided the reservation is cancelled no less than 48 hours prior to 12:00 noon on the arrival date. Cancellation Fee is 15% of total reserved slip amount or \$25.00 whichever is greater. If the reservation is cancelled less than 48 hours prior to 12:00 noon on the arrival date, then the entire deposit is forfeited. Vessels over 75' cancelling, forfeit entire deposit regardless of when reservation is cancelled. In the event the reservation is not cancelled, and the above vessel fails to arrive, regardless of reason, Liberty Landing Marina will charge the below credit card for the total reserved slip amount. DEPOSITS WILL BE HELD FOR 1 YEAR, IF NOT USED AFTER 1 YEAR, DEPOSIT WILL BE FORFEITED.
- **Measurement Policy:** OpCo charges for the entire overall length of a vessel and its appurtenances. If the overall length, as measured by OpCo, is 2 feet, or more, greater than the indicated length above, the additional length will be charged at twice the prevailing transient rate.
- **Multihull Vessels:** Catamarans will be charged 1.5 times and trimarans will be charged at 2 times the prevailing transient rate.
